Subject: Affidavit in Support of Application for Enrollment

Affidavits are required when parents or legal guardians are living with a friend or relative who is a Berkley School District Resident; thus, proof of residency is limited. Please complete the affidavit as follows and provide the appropriate proof of residency. For School of Choice families, please have your landlord complete the portion that states "Berkley School District Resident".

- 1. Part 1 of the affidavit is to be completed by the parent or legal guardian.
- 2. Part 2 of the affidavit is to be completed, signed and dated *in the presence of a Notary Public* by the Berkley School District resident.
- 3. Part 3 of the affidavit is to be completed, signed and dated *in the presence of a Notary Public* by the parent or legal guardian
- 4. The resident must provide 5 current residency pieces verifying their residence (driver's license showing the current BSD resident address, tax statement **and** property deed/mortgage OR lease and Statement of Landlord, 2 utility bills). See list below.
- The parent or legal guardian must provide 3 current residency pieces verifying their residence (driver's license showing the current BSD resident address and 2 pieces of business communication). See list below.

Examples of Business Communications:

- Cable/Satellite TV bill
- IRS bill or statement
- Phone bill

- Bank statement
- Auto loan/insurance
- Professional license

- Paycheck stub
- DHS statement
- Medical bills
