- School dismissal is at 3:20 PM.
 - Kindergarten is dismissed at 3:15 PM

Drop-Off and Pick-Up

- Drop-Off
 - Line up with their class at assigned door
 - Enter school on their own
 - Parents say goodbye on the sidewalk
 - Locker
 - Hang up their coat
 - Empty backpack
 - Take home folder/notes/homework
 - Order lunch

Pick-Up

- Dismissal at 3:15
- Students exit from assigned door
- Teacher will dismiss each child one at a time to their parent or adult specified on emergency card
- If you are not able to pick up your child by 3:20, they will be walked to the office to wait for you there.

Bond Proposal Details

\$88,000,000 to invest in

- District-wide classroom furniture
- Multi-purpose additions at all elementary schools
- Performing arts upgrades and additions
- Athletics upgrades and additions
- District-wide technology upgrades

What Would the Proposal Cost?

- \$88,000,000 would be a 2.25 mill increase, starting in 2024
- Each homeowner's cost may be different depending on filing status, age and other income tax variables
 - An example: A home worth \$200,000 typically has a taxable value of \$100,000. An additional 2.25 mills levied on this home would cost \$225/year, before any income tax considerations. However, your costs may be less.
- This is 2.25 mills on the taxable value of a home, not the total value
- Tax calculator on the website
- Ultimately, this Bond would cost on average less than a dollar a day
